a. President's Report

- i. Lallah Howard has stepped forward, applying to join the board of directors of The ACBV. Lallah is a CPA and has agreed to also assume the role of Treasurer. An email motion was sent to the Board Members on July 3, 2024, at 3:38 PM, Elizabeth Cunha initiated the motion with the first affirmative vote. At 3:48 PM, Larry Zuber made the second affirmative vote, seconding the motion. At 8:27 PM, Michael Kilgore entered the seventh positive vote and completed the quorum. During and after this period, there were no dissenting votes. The motion: "As of Wednesday, July 3, 2024, The Arts Council of Brazos Valley Board of Directors approve Lallah Howard's request to join The Arts Council of Brazos Valley Board of Directors and appoint her to the role of Treasurer for The Arts Council of Brazos Valley, starting immediately." was approved. Please join me in welcoming Lallah Howard to the board as Treasurer.
- ii. On June 21, 2024, the Executive Committee and the Selection Committee request a motion be made and a vote be taken to extend a competitive offer to hire a new Chief Executive Officer. The motion: "As of June 21, 2024, the ACBV Board of Directors agrees to grant the Interim CEO/ED the authority to extend an offer to the candidate identified by the Selection Committee on June 20, 2024, in conjunction with a quorum of the Executive Committee of The Arts Council of Brazos Valley Board of Directors." was proposed by Cindy Roberts at 1:55 PM and seconded at 2:47 by Julie Freeman. At 3:40 PM a total of eight (8) votes had been submitted and the motion passed. During this time no negative votes were received.
- iii. Due to Mark Scarborough's resignation as Treasurer the following email motion: "As of June 21, 2024, The Arts Council of Brazos Valley Board of Directors appoint Grover Vos, FY2024, Interim CEO/ED and President as the primary administrator at all financial institutions where The Arts Council of Brazos Valley does business. Also, The Arts Council of Brazos Valley Board of Directors appointed Grover Vos, FY2024, President; Warren Finch, FY2024 Past President; and Julie Freeman, FY2024, Secretary, to have signatory authority for all financial institutions where The Arts Council of Brazos Valley does business.", was sent. The motion was proposed by Dr. Carol Fox Henrichs at 3:41 PM on June 21, 2024, and seconded at 3:42 by Cindy Roberts. At 10:58 PM, June 21, 2024, seven (7) votes had been submitted and the motion passed. No negative ballots were received during or following the voting period. Based on the approval of Lallah Howard as our Treasurer, a motion is requested to add her to the list of those to have signatory authority for all financial institutions where The Arts Council of Brazos Valley does business.
